## Auditors' report in accordance with Chapter 8, § 54 of the Swedish Companies Act (2005:551)

### *Introduction*

We have audited whether the Board of Directors and the President of Investor AB (publ.) have complied with the guidelines for remuneration to Group Executive Management during the financial year 2008 which were approved by the Annual Meeting of the Shareholders held on March 27, 2007 respectively by the Annual Meeting of the Shareholders held on April 3, 2008. We believe that our audit procedures provide a reasonable basis for our opinion as set out below.
