This document contains references to information in Investor's Annual Report 2022, that are relevant for the SASB sustainability accounting and activity metrics applicable to the Company.

The Sustainability Accounting Standards Board (SASB) Standard closest to Investor AB's industry activities, is the "Asset Management & Custody Activities Sustainability Accounting Standard", however it is important to note that Investor does not manage investment portfolios on a commission or fee basis for institutional, retail or high net worth investors, nor does it provide advisory or other services. It should be noted that Investor does not have any customers or clients. Investor is an industrial holding company and allocates capital in the same way a private equity firm would, building a buy-to-build portfolio of long-term investment holdings in high-quality, global companies. Investor builds strong and sustainable businesses through engaged ownership.

Investor publishes this document to facilitate external stakeholders' access to SASB-related information and it is intended to be used together with Investor's Annual Report. This marks the first time that Investor is mapping its environmental, social and governance performance disclosures with reference to the SASB framework. Investor is not providing disclosures on all metrics prescribed in the applicable standard and where omissions are made, this is indicated in the index.

Patricia Industries' investee companies are operated independently and hence not included within Investor AB's sustainability reporting. In Investor's Annual Report 2022, the wholly owned subsidiaries have their own respective sustainability sections located on pages 30-41 and 71-73. The listed portfolio companies and some of the companies within Patricia Industries also publish their own sustainability reports. The answers below relate to Investor AB.
